Minimalstaat Bodo Knoll 2008 English summary: In his famous work, *Anarchy, State, and Utopia*, the political philosopher Robert Nozick justified a minimal state. The state should be constrained to guarantee individual rights. Due to the entitlement theory of justice, any distribution of holdings is supposed to be justified if no coercive violation of natural rights has taken place during the initial acquisition of previously unowned things and subsequent transfers. Unjust transactions of the past have to be corrected. Bodo Knoll compares Nozick's arguments with alternative libertarian theories of the state. Beispielsweise begünstigen Nozicks Annahmen über den anarchischen Naturzustand die Ableitung eines Minimalstaats. Marktversagenstatbestände betreffen nicht nur das Gut Schutz. Bodo Knoll diskutiert, ob absolute und vollständige Eigentumsrechte widerspruchsfrei aus der Anspruchstheorie begründet werden können und ob die resultierende Eigentumsverteilung eine intergenerative Ungerechtigkeit darstellt. Zudem erweist sich die Berichtigung ungerechter Aneignungen und Transfers angesichts fehlender Informationen als schwierig. Nozicks Kritik an strukturellen Gerechtigkeitsgrundsätzen führt in ein Dilemma, weil auch die Anspruchstheorie einen vagen Gerechtigkeitsbegriff definiert.
